Re: Vaping and drugs

Staffordshire Police have made us aware of concerns about new drugs trends young people may be exposed to, particularly around using vapes. We would remind you that it is illegal to buy vaping devices and liquids under the age of 18 and our school policy is to confiscate vaping devices and liquids and suspend students suspected of using them. If we believe that drugs are being used in vapes, we would also inform the police.

While e-cigarettes have health benefits over smoking cigarettes, it is important that the vaping liquid has been quality controlled. There are a number of vaping liquids available from unlicensed sources such as the dark web or advertised on social media that have not been controlled, a number of which contain illegal, harmful substances.

THC - tetrahydrocannabinol

There has been an increase in young people using vapes and in particular experimenting with THC vaping. THC is the psychoactive compound in cannabis and is illegal in the UK. The latest reports show that this has led to some young people overdosing on THC, causing them to become unwell and needing medical attention.

How do I know if my child is vaping THC?

Vaping tends to produce clouds of smoke that are scentless and disappear quickly, so it can be difficult to sense if your child is using a vape. Vaping THC will have similar effects to using cannabis. Vaping THC as opposed to smoking cannabis allows a larger amount of THC to be inhaled very quickly, potentially causing overdosing. The effects of vaping THC depends on the amount of THC/CBD in the vape, your child's mood, the environment and how often it is used.

The side effects are listed below and can be signs your child has vaped THC oil:

- Blood shot eyes
- Dazed/dreamy demeanour
- Light headedness, dizziness, confusion and tiredness
- Hot flushes, excessive sweating
- Mood swings excited, agitated and aggressive
- Short term memory loss
- Faint, feeling sick, vomiting
- The giggles, munchies, dry mouth
- Anxiety, paranoia, hallucinations
- Suicidal thoughts
- Tremors, seizures and fits.











The liquid can be distributed in drink bottles and decanted into smaller, unlabelled bottles (see below).



What is the law?

Cannabis is an illegal Class B drug. There are consequences for the illegal possession, supply and production of cannabis:

- *Possession* having (possessing) cannabis in any form, including edibles, can get you up to 5 years in prison, unlimited fine or both.
- Supply supplying cannabis which includes giving it to your friends for free or sharing it with them can get you up to 14 years in prison, an unlimited fine or both.
- Dealing selling cannabis for any sized financial gain can get you up to 14 years in prison, an unlimited fine or both.
- *Trafficking* moving it around the country on transport or through private vehicle etc. can get you up to 14 years in prison, an unlimited fine or both.
- *Production* producing cannabis whether growing for self-consumption or to be sold can get you up to 14 years in prison, an unlimited fine or both.

Young people who use cannabis are at increased risk of child criminal exploitation (CCE), and to be groomed into County Lines operations.

"Spice" or "Mamba"

Further concerns are raised after reported cases where young people had suffered adverse effects following buying and vaping what they believed to be THC but was later identified as a far more potent substance, "Spice" or "Mamba", the effects of which required hospital treatment.

What can I do as a parent / carer?

We recommend monitoring for vaping devices, liquids and equipment as pictured above. On packaging and wrappers look for wording such as CBD or THC suggesting the items are cannabis oil infused.

We would advise you to talk to your child about drugs and don't wait until there's a problem before you decide to talk. Take time to listen to what they have to say and discuss the risks associated with substance misuse and possible consequences of their actions and support them to make the right choices.

Please be mindful of the medical needs should a child present with symptoms, or if you suspect they have consumed a drug-infused substance. In a medical emergency, always call 999.
